### Coalition Effectiveness Survey Results Revealed!

125 members completed a survey to measure their perceptions of the effectiveness of the Coalition. Areas of significant improvement from the 2010 baseline results include:

- Member engagement (sharing a common vision, members' abilities are effectively used, members' level of commitment)
- Leadership (exploring all points of view, managing conflict)
- Communication quality and frequency between members
- Decision making (consensus building)
- Cohesiveness and unity
- Satisfaction with the work of the Coalition
- Outcome: the Coalition is likely to improve patient safety in the community

# The Results are In! Healthcare Worker Flu Vaccination to improve Patients' Safety

Community Health Network, IU Health, St. Francis Health and Wishard hospital implemented the Coalition policy requiring healthcare worker Flu vaccination with outstanding compliance results:

- Voluntary Compliance Rate during 2010-2011 Flu Season = 59%
- Mandatory Compliance Rate during 2012-2013 Flu Season = 98.5%
